TOWN BOARD PROCEEDINGS

The Town Board of South Shore met for their regular meeting on Tuesday December 7, 2021, at 7:00pm at the South Shore Community Center. Those present were Council Members Schmeichel and Dolen. M. Klatt was unable to attend. Also present were FO Zirbel, C. Werner, P. Nelson, K. Nelson, S. Jackson, J. Jackson, Q. Jackson, B. Meyer, and C. Crouse from 1st District.

The meeting was called to order at 7:00pm by Dolen followed by the Pledge of Allegiance.

A motion was made by Schmeichel, seconded by Dolen to approve the agenda.

The financial report was given reflecting the following fund balances: General Fund \$162,240.98, Water Fund \$53,043.38, Sewer Fund \$127,417.68, Sewer Surcharge fund starting January 2021 through November 30, 2021, \$8,366.11, Water deposits starting January 2021 through November 2021 500, CD's \$32,701.57 Outstanding sewer loan \$191,538.15.

NEW BUSINESS (1) Public input: J. Dolen shared positive input for all the changes South Shore has incurred in the last few months. Happy with the direction the town is going. (2) C. Crouse from 1st District attended the meeting with information regarding water system improvement project. Discussion on costs, loan amounts, grants and phasing projects were discussed. Resolution 2021-06, Resolution authorizing an

application for financial assistance, authorizing the execution and submittal of the application, and designating an authorized representative to certify and sign payment requests was read. Motion to approve by Dolen seconded by Schmeichel. Motion passed. (3) Water/Sewer maintenance report lift station is to be repaired. (4) SDARWS annual conference is in January 2022. C. Werner requested to attend for continuing education. Motion to send to conference and pay membership dues by Dolen, seconded by Schmeichel. Motion passed. (5) First reading of Ordinance No. 2021-1-175 Supplemental Appropriation Ordinance for the Town of South Shore was read. Second reading will by at the special meeting December 20, 2021 at 6.30.

With no further business, Schmeichel moved, seconded by Dolen to adjourn at 7:58. Motion carried.
